AFTER REVISING THE INFORMATION PROVIDED ON YOUR FILE, WHICH IS UNDER CONTROL OF THIS AGENCY AND ONCE REVISED THE FOLLOWING:

CONSIDERATIONS:

1.- ON SEPTEMBER 2, 2005, THE DGGIMAR PROVIDES THE AUTHORIZATION 02-03-PS-VI-03-2005 (RENEWAL) UNDER OFICIAL MEMO NUMBER DGGIMAR.710/004689 WITH A VALID DATE OF 5 YEARS, FOR THE RECYCLING OF HAZARDOUS WASTES (SPENT SOLVENTS), WITH AN ANNUAL CAPACITY OF 4,903 TONS;

2.- ON JANUARY 1, 2008 IT WAS FILED THE PETITION NUMBER 09/HS-0002/01/08 TO MODIFY AND ADD MORE WASTES TO RECYCLE ANDER THE AUTHORIZATION No. 02-03-PS-VI-03-2005, SUCH LIKE:

- AROMATIC SPENT SOLVENTS (TOLUENE, XYLENE, BENZENE, ETHYL BENZENE, M-CRESOL)

- ALIPHATIC SOLVENTS AND HYDROCARBONS (NAPHTHA, N-PENTANE, N-HEXANE, N-HEPTANE, MINERAL SPIRITS, VM&P NAPHTA, STODDARD SOLVENT, KEROSENE, JP-5)

- ALCOHOLS (METHANOL, ISOPROPANOL, ETHANOL, N-BUTYL ALCOHOL, ISOBUTYL ALCOHOL, CYCLOHEXANOL, N-HEXANOL)

- KETONES (ACETONE, METHYL ETHYL KETONE, DIETHYL KETONE, METHYL N-PROPYL KETONE, CYCLIHEXNONE, METHYL ISOBUTYL KETONE, METHYL CYCLOHEXANONE, ACETONIL ACETONE, DIISO PROPYL KETONE, METHYL N-AMIL KETONE, DI ACETONE)
